 - I. 頭50個座位: 每年每座位收費為港幣一百一十五元
第51至100個座位: 每年每座位收費為港幣九十二元
第101至200個座位: 每年每座位收費為港幣七十一元
第201個座位或以後: 每年每座位收費為港幣二十三元
例如: 某中式酒樓最高可容納的座位為120個:
應繳付的總牌照費為港幣一萬一千七百七十元 (\$115 x 50 + \$92 x 50 + \$71 x 20)
 - II. 最低牌照費為每年每間中式酒樓港幣五千五百二十元
- 3 **適用於的士高**
 - I. 總容納人數不超過50人: 每年收費為港幣十萬零八千四百一十三元
總容納人數為51至100人: 每年收費為港幣十五萬二千一百二十四元
總容納人數為101至200人: 每年收費為港幣十九萬七千五百二十六元
總容納人數為201人或以上: 每年收費為港幣二十四萬三千八百四十二元
 - II. 如的士高每日平均營業時間少於8小時, 則全年應繳付的牌照費可享有20%折扣
- 4 **適用於髮廊及美容院**
 - I. 每年每座位收費為港幣二百三十八元五角
 - II. 最低牌照費為每年每間髮廊或美容院港幣一千九百零八元
- 5 **適用於酒店及賓館**
 - I. 頭500個房間: 每年每房間收費為港幣一百四十一元五角
第501個房間或以後: 每年每房間收費為港幣八十元
 - II. 最低牌照費為每年每間酒店或賓館港幣一萬四千一百五十元
- 6 **適用於夜總會、舞廳及跳舞廳**
 - I. 每年每座位收費為港幣一百四十三元
 - II. 最低牌照費為每年每間夜總會或舞廳或跳舞廳港幣二千七百一十七元
- 7 **適用於食肆 (中式酒樓除外)**
 - I. 每年每座位收費為港幣一百五十七元五角
 - II. 最低牌照費為每年每間食肆港幣二千九百九十五元
- 8 **適用於零售店**
 - I. 每年每平方米收費為港幣四元零七仙
 - II. 最低牌照費為每年每間零售店港幣一千九百三十元

1. **Bars & Lounges**
 - a. HK\$317.00 per seat per annum
 - b. Minimum licence fee: HK\$8,560.00 per bar or lounge per annum
2. **Chinese Restaurants**
 - a. For the first 50 seats: HK\$115.00 per seat per annum
51-100 seats: HK\$92.00 per seat per annum
101-200 seats: HK\$71.00 per seat per annum
201 or above: HK\$23.00 per seat per annum
e.g. For a Chinese Restaurant with maximum accommodation of 120 seats:
The total licence fee will be HK\$11,770.00 (\$115 x 50 + \$92 x 50 + \$71 x 20)
 - b. Minimum licence fee: HK\$5,520.00 per restaurant per annum
3. **Discotheques**
 - a. Maximum accommodation of 50 persons: HK\$108,413.00 per annum
Maximum accommodation of 51-100 persons: HK\$152,124.00 per annum
Maximum accommodation of 101-200 persons: HK\$197,526.00 per annum
Maximum accommodation of 201 or above: HK\$243,842.00 per annum
 - b. For discotheques with average daily operating hours less than 8 hours, 20% of the annual licence fee payable will be deducted.
4. **Hairdressing & Beauty Salons**
 - a. HK\$238.50 per seat per annum
 - b. Minimum licence fee: HK\$1,908.00 per salon per annum
5. **Hotels & Guesthouses**
 - a. For the first 500 rooms: HK\$141.50 per room per annum
501 or above: HK\$80.00 per room per annum
 - b. Minimum licence fee: HK\$14,150.00 per hotel or guesthouse per annum
6. **Night Clubs, Ballrooms & Dancing Halls**
 - a. HK\$143.00 per seat per annum
 - b. Minimum licence fee: HK\$2,717.00 per night club, ballroom or dancing hall per annum
7. **Restaurants (Except Chinese Restaurants)**
 - a. HK\$157.50 per seat per annum
 - b. Minimum licence fee: HK\$2,995.00 per restaurant per annum
8. **Retail Stores**
 - a. HK\$4.07 per sq.ft. per annum
 - b. Minimum licence fee: HK\$1,930.00 per store per annum
