  - I. 每年每座位收費為港幣三百五十六元
  - II. 最低牌照費為每年每間酒吧或酒廊港幣九千六百一十二元
2. **適用於中式酒樓**
  - I. 頭50個座位：每年每座位收費為港幣一百二十六元  
第51至100個座位：每年每座位收費為港幣一百元  
第101至200個座位：每年每座位收費為港幣七十八元  
第201個座位或以後：每年每座位收費為港幣二十五元  
例如：某中式酒樓最高可容納的座位為120個：  
應繳付的總牌照費為港幣一萬二千八百六十元  $(\$126 \times 50 + \$100 \times 50 + \$78 \times 20)$
  - II. 最低牌照費為每年每間中式酒樓港幣六千三百元
3. **適用於的士高**
  - I. 總容納人數不超過50人：每年收費為港幣十二萬二千五百元  
總容納人數為51至100人：每年收費為港幣十七萬二千元  
總容納人數為101至200人：每年收費為港幣二十二萬三千元  
總容納人數為201人或以上：每年收費為港幣二十七萬六千元
  - II. 如的士高每日平均營業時間少於8小時，則全年應繳付的牌照費可享有20%折扣
4. **適用於髮廊及美容院**
  - I. 每年每座位收費為港幣二百六十七元
  - II. 最低牌照費為每年每間髮廊或美容院港幣二千一百三十六元
5. **適用於酒店及賓館**
  - I. 頭500個房間：每年每房間收費為港幣一百六十元  
第501個房間或以後：每年每房間收費為港幣九十元
  - II. 最低牌照費為每年每間酒店或賓館港幣一萬六千元
6. **適用於夜總會、舞廳及跳舞廳**
  - I. 每年每座位收費為港幣一百五十八元
  - II. 最低牌照費為每年每間夜總會或舞廳或跳舞廳港幣三千一百六十元
7. **適用於食肆（中式酒樓除外）**
  - I. 每年每座位收費為港幣一百七十三元
  - II. 最低牌照費為每年每間食肆港幣三千四百六十元
8. **適用於零售店**
  - I. 每年每平方尺收費為港幣四元六角
  - II. 最低牌照費為每年每間零售店港幣二千三百元

With effect from 1 January 2025, the following tariffs will be in force: -

1. **Bars & Lounges**
  - a. HK\$356.00 per seat per annum
  - b. Minimum licence fee: HK\$9,612.00 per bar or lounge per annum
2. **Chinese Restaurants**
  - a. For the first 50 seats: HK\$126.00 per seat per annum  
51st – 100th seats: HK\$100.00 per seat per annum  
101st – 200th seats: HK\$78.00 per seat per annum  
201st or above: HK\$25.00 per seat per annum  
e.g. For a Chinese Restaurant with maximum accommodation of 120 seats:  
The total licence fee will be HK\$12,860.00  $(\$126 \times 50 + \$100 \times 50 + \$78 \times 20)$
  - b. Minimum licence fee: HK\$6,300.00 per restaurant per annum
3. **Discotheques**
  - a. Maximum accommodation of 50 persons: HK\$122,500.00 per annum  
Maximum accommodation of 51 – 100 persons: HK\$172,000.00 per annum  
Maximum accommodation of 101 – 200 persons: HK\$223,000.00 per annum  
Maximum accommodation of 201 or above: HK\$276,000.00 per annum
  - b. For discotheques with average daily operating hours less than 8 hours, 20% of the annual licence fee payable will be deducted.
4. **Hairdressing & Beauty Salons**
  - a. HK\$267.00 per seat per annum
  - b. Minimum licence fee: HK\$2,136.00 per salon per annum
5. **Hotels & Guesthouses**
  - a. For the first 500 rooms: HK\$160.00 per room per annum  
501st or above: HK\$90.00 per room per annum
  - b. Minimum licence fee: HK\$16,000.00 per hotel or guesthouse per annum
6. **Night Clubs, Ballrooms & Dancing Halls**
  - a. HK\$158.00 per seat per annum
  - b. Minimum licence fee: HK\$3,160.00 per night club, ballroom or dancing hall per annum
7. **Restaurants (Except Chinese Restaurants)**
  - a. HK\$173.00 per seat per annum
  - b. Minimum licence fee: HK\$3,460.00 per restaurant per annum
8. **Retail Stores**
  - a. HK\$4.60 per sq.ft. per annum
  - b. Minimum licence fee: HK\$2,300.00 per store per annum
