51st - 100th seats: HK\$102.00 per seat per annum
101st - 200th seats: HK\$79.00 per seat per annum
201st or above: HK\$25.00 per seat per annum
e.g. For a Chinese Restaurant with maximum accommodation of 120 seats:
The total licence fee will be HK\$13,080.00 (\$128 x 50 + \$102 x 50 + \$79 x 20)
Minimum licence fee: HK\$6,400.00 per restaurant per annum
- Discotheques**
 - Maximum accommodation of 50 persons: HK\$124,500.00 per annum
Maximum accommodation of 51 - 100 persons: HK\$174,500.00 per annum
Maximum accommodation of 101 - 200 persons: HK\$226,500.00 per annum
Maximum accommodation of 201 or above: HK\$280,000.00 per annum
For discotheques with average daily operating hours less than 8 hours,
20% of the annual licence fee payable will be deducted.

- Hotels & Guesthouses**
 - For the first 500 rooms: HK\$162.00 per room per annum

Minimum licence fee: HK\$16,200.00 per hotel or guesthouse per annum
- Night Clubs, Ballrooms & Dancing Halls**
 - HK\$160.00 per seat per annum
 - Minimum licence fee: HK\$3,200.00 per night club, ballroom or dancing hall per annum
- Restaurants (Except Chinese Restaurants)**
 - HK\$175.00 per seat per annum
 - Minimum licence fee: HK\$3,500.00 per restaurant per annum
